Collaboration with CoE-NDDS, NIPER Raebareli

National Institute of Pharmaceutical Education and Research (NIPER) Raebareli invites Expression of Interest from Industries, MSMEs, Fund Grantees and Startups for collaboration (incubation/consultancy/contract research) at Centre of Excellence (CoE)-Novel Drug Delivery System (NDDS). CoE-NDDS, NIPER Raebareli has clear goals where pharmaceutical research and its translation in the broader domain of NDDS can be pursued under the thrust areas:

1. Formulations of complex APIs,
2. Complex formulations,
3. Novel routes and novel dosage forms and
4. Innovative drug-device combinations.

CoE-NDDS, NIPER Raebareli

CoE at NIPER Raebareli aims to prioritise and promote research in developing novel pharmaceutical formulations with translational potential. CoE at NIPER Raebareli has been established to tackle and overcome the limitations associated with the existing drug delivery systems and to innovate new drug delivery systems against various diseases. Cutting-edge research and analytical facilities built under CoE will foster innovations in NDDS that lead to entrepreneurial advancements. Collaboration with CoE may fall under incubation, consultancy, contract research. Innovators working in Pharmaceutical-based research may associate with CoE under the listed categories.

- a. **Internal/Indigenous Project:** Industry, Startups and MSMEs may collaborate with CoE by associating with internal projects which have the basic PoC in place.
- b. **Joint Venture (Partnership):** Industry, Startups and MSMEs may collaborate with CoE in a joint venture or partnership for projects designed with their mutual interest.
- c. **Consultancy:** Under the consultancy, Industry, startups and MSMEs may collaborate under CoE, and utilize the facility for consultancy services. Collaborators must pay the facilitation fee to the CoE-NDDS, NIPER Raebareli, and the problem solving would be done by CoE.
- d. **Plug and Play:** CoE also provides an opportunity to industry, startups and MSMEs to utilize the facility under plug and play. Under the plug and play, since the facility at CoE is being utilized hence the collaborator will be paying a facilitation fee.
- e. **Incubation:** Innovators and technopreneurs working in Pharmaceutical, Nutraceuticals and Excipients manufacturer can avail CoE incubation facility for validation of ideas, testing MPV, and development of products from Lab to commercialization/Tech transfer in the domain of NDDS.

Pharmaceutical innovators may utilize the facilities:

- 1) Access to Resources (Laboratories, Animal House & Central Instrumentation Facility)
- 2) Coworking space
- 3) Seed Funding (based on expert recommendations)
- 4) Mentorship (NIPER Raebareli and CoE-NDDS)
- 5) Networking (pre-incubation, co-incubation and funding)
- 6) Training and idea validation
- 7) Intellectual Property (IP) Support
