National Institute of Pharmaceutical Education and Research (NIPER), Raebareli was established in year 2008 following the amendment of the NIPER Act, 1998 by the Parliament in year 2007. It is an autonomous Institute with its own Board of Governors and functions under the aegis of Department of Pharmaceuticals, Ministry of Chemicals & Fertilizers (MoCF), Government of India with the objective of meeting the increasing demands for skilled pharmaceutical professionals, developing new pharmaceutical technologies, and conducting fundamental research in the area of new drug discovery. Since its inception, NIPER-Raebareli has operated with the goal of fulfilling the pharmaceutical needs of the country by fostering collaboration among academia, research, and development (R&D), and industry through training and research initiatives. NIPER Raebareli, which initially began with two departments in 2008, currently houses five departments, namely Medicinal Chemistry, Pharmaceutics, Pharmacology and Toxicology, Regulatory Toxicology, and Biotechnology. These departments are actively engaged in various aspects of teaching and research activities. The institute offers **M. S. (Pharm.)** courses in five disciplines along with **Ph.D.** programs in four disciplines, contributing significantly to the advancement of research and development (R&D) activities in pharmaceutical research. The total Staff Strength of NIPER-Raebareli is 37 at Present and total enrolment across the programs is 311 students.

NIPER-Raebareli is actively seeking to empanel Multi-Speciality / Single-Speciality Hospitals and Diagnostics Centres located in Lucknow on CGHS Rates. This initiative aims to ensure that the Regular Staff members of NIPER-Raebareli have access to quality healthcare services at standardized rates. By empanelling such healthcare facilities, NIPER-Raebareli intends to enhance the well-being of its staff and promote a healthy work environment. This will enable the further process of empanelment to be initiated from both parties.

Those Multi-Speciality / Single-Speciality Hospitals and Diagnostics Centres located in Lucknow, which are willing to collaborate and provide their services to the Staff / Students of NIPER-Raebareli but are not willing to come under the CGHS Scheme, opting instead for mutually agreed **Special Discounted Rates**, may also submit their application along with all supporting documents to this office. This will enable the initiation of the mutual agreement process between both parties.

Interested Multi-Speciality / Single-Speciality Hospitals and Diagnostics Centres located in Lucknow are encouraged to participate by submitting their application in accordance with the detailed instructions and application form provided in Annexure - A. This application process ensures transparency and standardization in the empanelment procedure. Hospitals and Diagnostics Centres willing to collaborate with NIPER-Raebareli on CGHS Rates or mutually agreed discounted rates can use the provided format to provide necessary information and supporting documents. The detailed instructions and application form in Annexure - A aim to streamline the empanelment process, making it accessible and comprehensive for all potential healthcare providers interested in partnering with NIPER-Raebareli.

3. The applicant must indicate under which category the application is being made & all the pages of Application and annexure shall be serially numbered.
4. Each page of application should be signed by an authorized signatory of the Hospital / Diagnostic Centre / Pathology lab bearing his / her full name and status, clearly indicated below the signature along with the official seal of the Hospital / Diagnostic Centre / Pathology Lab.
5. Application form should be submitted in one sealed envelope superscribed as "Application for Empanelment of Private / Reputed Hospital / Diagnostic Centre / Pathology Labs".
6. Application / Expression of Interest (EoI) duly filled in documents, complete in all respects should reach the office of ***The Registrar, Transit Campus of NIPER Raebareli, Bijnor - Sisendi Road, Post - Mati, Ahmadpur urf Kamlapur, Sarojini Nagar, Lucknow -226002.***
7. Last date for submission of Application / EoI is **21-05-2024 (Tuesday) up to 01:00 P.M.** Application will be opened at **03:00 P.M.** on same day in the presence of the tenderers or their representatives, if they so desire, at Transit campus of NIPER Raebareli, Lucknow.
